TERMS, AGREEMENT & PERSONAL GUARANTY

By signing below, each person signing this application does so both on behalf of the Applicant and individually, in their personal capacity as a Guarantor, and agrees to each of the following:

Payment Terms. Terms are 1% 10 days, net 30, past due thereafter. A service charge of 1½% per month (18% per annum) applies to all past-due balances, and each Guarantor personally agrees to pay those charges as they accrue.

Personal Guaranty.
